Dear Colleagues

As you will know after decisions taken in the Scottish Parliament all local authority areas have been placed into a covid-19 protection level. Have a look at the table below and ensure that you understand which level applies to your parish and church building.

I've also attached a pdf with a table for each protection level and how it affects churches. Have a look at the appropriate table to ensure that you and your Kirk Session comply with the particular level of restrictions applicable to your setting. The restrictions (and permissions) come into effect next Monday (2nd November) so it is very important that you make any alterations which are needed to the ways which we organise worship, use the church building and organise our common life. These levels are set out in law approved by the Scottish Parliament and, therefore, they *need* to be followed. Should you wish to read the full Scottish Government Covid-19 Strategic Framework it can be accessed here.

The Covid group recognise that a small number of parishes will straddle two local authority areas. If this affects your situation you may have some rules in place for your church building and another set for parts of the parish. This may have implications for ministers and staff travelling to work. Whilst the First Minister has asked that those in level 3 areas should not leave their council area but there are exemptions in place for work, health care and support, and attending things like funerals and weddings.

Finally, now that levels have been confirmed we can issue final thoughts on Remembrance Sunday. It should be noted that unless your area is in level 0 or 1 outdoor live events are not permitted at this time. This would include an act of remembrance at a War Memorial outwith the grounds of a place of worship. If the memorial is in the church grounds the "Place of Worship" regulations apply – for example, the maximum of fifty attendees where space allows plus the other preparations to ensure people's safety. I recognise that this will disappoint many but there may be creative ways in which you can still lead your community in an Act of Remembrance using other methods of delivery.

In the near future we hope to be able to target emails to areas that change levels, but for now, please ensure that you are aware of the restrictions for your area.

In the meantime please keep abreast of the current version of the Church of Scotland Guidance.
